

Whether it is attending P&Z meetings to help educate residents via social media or reaching out to companies to tell them how great of a city Maricopa is, I try my best to be involved. I think I would be able to represent the new generation that is helping this city grow as well as bring a new perspective to challenges that our city currently faces. Having gone to Virginia Military Institute, I am prepared for long nights of discussing policies and making the right decision for the city even if it might be an unpopular one. Furthermore, VMI instilled their core values of honor, character, and service in me, and I believe those values transfer right into being a City Councilmember.

I would be one of the youngest members to ever sit on City Council which would greatly diversify it and I would be able to give an ear to the new generation that is helping grow Maricopa. I would also bring a technical background to the City Council. Right now most of the complaints about the city are voiced on social media and addressed by a few members of city staff. I am already active on social media in quick defense of the city and sometimes calling it out for things that could be improved. In today's world I think being tech savvy and being on the platforms where your constituents are is super important. Above all else, I feel like I am one of the few of the younger generation that has a fiery passion for the City of Maricopa.

In 300 words or less, please discuss the three (3) most important issues you see facing the City of Maricopa today.

In 2020, \$370 million of annual retail leakage occurred. We need to focus on bringing that back into Maricopa instead of having it spent in surrounding cities. About \$35 million of that is food and drink and I think the city is doing a good job at addressing those needs with Cold Beer & Cheeseburgers, Nandos, Cocina Madrigal, and Chilis. However, there is a lot that needs to be addressed in terms of clothing, furniture, sporting goods, and home improvement.

Maricopa was once a bedroom community but it was quickly discovered that a bedroom community is not sustainable. Due to this we need to do better at having more affordable housing like condos, apartments, and bungalows to supply the staffing shortage we have here. Places like Banner Health can't keep doctors here because most of them have to drive an hour or more to get here which isn't sustainable. Furthermore, places like Starbucks and Dunkin' Donuts are forced to close their doors and only serve through drive through due to not enough people.

The item that gets talked about the most by residents of Maricopa, transportation. The 347 is currently the only way in and out of the city and can be backed up for miles on a bad day. Everyone, I would hope, knew about this one way in and out before moving here, but how do we educate? Widening 347 still isn't

going to stop people from going 100 down the emergency lane, how do we get State Troopers to police it more? Lastly, how do we work at having a better flow of traffic around the city? I know the city is working with AZ DOT to gain control of 347 and 238 within city limits, but what else can we do?

First and foremost, the public success based on our policies is what defines our success as a City Council. If the public isn't successful, then we have done something wrong as a Council. However, even if we are convinced that our policy is for the greater good, the reality might be something completely different. When something like that happens you have to listen to your constituents and go back to the drawing board. Even though we aim to be right on the money with every decision we make, we won't and we will have to start all over. I also think being inclusive and transparent is key to being a good policy maker and serving the common good. We need to make sure that not only are the voices of residents of Maricopa heard, but also the voices of our fellow City Councilmembers. Without them and each other, we won't achieve legitimate success.
